## **Civmec Awarded EPC Contract**

**SINGAPORE – 10 April 2017** – Australia-based **Civmec Limited** (“**Civmec**” or the “**Group**”) has, as part of the Amec Foster Wheeler Civmec JV (ACJV), been issued a Notice to Proceed by the Gruyere Project Joint Venture (a 50:50 unincorporated joint venture between Gold Road Resources Limited and Gruyere Mining Company Pty Ltd, a wholly owned subsidiary of Gold Fields Limited) for an Engineering, Procurement and Construction (EPC) contract for the Gruyere Gold Project, located within the Yamarna greenstone belt, approximately 200 kilometres east of Laverton in Western Australia.

The scope of work includes the detailed design, procurement and installation of the process plant, administration office, workshop and warehouse, as well as the main water pipelines and powerlines to the borefield.

Engineering has commenced and onsite work is scheduled to start in July 2017. More than 300 personnel will be employed on the project at its peak, with practical completion scheduled for December 2018.

Mr. Patrick Tallon, Chief Executive Officer of Civmec, said, “As a tier one EPC contractor we look forward to transferring our knowledge of the project into the delivery of a successful overall outcome for all stakeholders. This is one of the largest and most prestigious projects in Western Australia and we are delighted to play a major part.”

“Civmec is dedicated to working closely with the local community on the project, we have developed a comprehensive local and indigenous engagement plan. With plans to self-perform the steel fabrication at our Henderson facility, this project emphasises Civmec as Australia’s largest globally competitive steel fabricator,” said Mr. Patrick Tallon.

The Amec Foster Wheeler Civmec JV (ACJV) is a 50:50 unincorporated joint venture between Civmec Construction and Engineering Pty Ltd and Amec Foster Wheeler Australia Pty Ltd.

Including the 50% share of this project, the Group’s order book has now reached its highest to date and stands at approximately S\$526 million.
