# Civmec Awarded A\$174 million of Contracts and Scope Extensions

Civmec Limited (“Civmec” or the “Group”, ASX: CVL, SGX: P9D) is pleased to provide an update of recent contract awards and scope extensions for approximately A\$174 million of fabrication, manufacturing, construction and maintenance work across a range of customer sectors nationally.

## **Dalrymple Bay Shiploader**

Civmec is pleased to announce the award of a significant contract for the supply, manufacture, and offsite assembly of a new shiploader for the Dalrymple Bay Terminal in Queensland, Australia.

The contract encompasses the supply, manufacture, and offsite assembly of the shiploader, which will be undertaken at Civmec’s state-of-the-art facility in Henderson, Western Australia. Leveraging the advanced capabilities of our Henderson facility, we will ensure the shiploader is built to the highest quality standards to enhance operational efficiency and reliability.

Following its manufacture, the shiploader will be fully assembled and no-load commissioned offsite and then transported via heavy lift vessel to the project site.

The project will create significant opportunities for local employment and subcontracting, reinforcing Civmec’s commitment to contributing positively to the communities in which we operate.

## **Maintenance**

Consistent with Civmec’s focus on maintenance services as a pillar of growth and recent completion of construction of its new Port Hedland maintenance facility, Civmec has recently secured a number of new contracts and work orders under existing term contracts and framework agreements across Australia, including:

- A shiploader travel bogie changeout project in the Pilbara region of Western Australia.
- Wharf remediation activities on both the east and west coasts of Australia.
- Risk management and inspection services, including structural and mechanical inspections, audits, stability and balance assessments, critical pin and weld non-destructive testing, wire rope inspections and similar complex activities in the Pilbara region.
- Balance Machine design and investigative work including design and supply of special tools, engineering assessments, repairs, refurbishments and supply of spare parts for clients on the east and west coast of Australia.
- Ongoing shutdown and maintenance work:
  - in the Pilbara region of Western Australia;
  - in the metropolitan area and south west of Western Australia for Alumina, Lithium and Cement clients; and
  - on the east coast of Australia for Alumina, Aluminium, and Explosives clients.

Plans for a new east coast maintenance hub in Gladstone are progressing, which is expected to further add to Civmec’s growth across the maintenance services sector nationally.
